1. Media Passes are limited in number so your application may not be considered even if you qualify with all the conditions.
2. No more than **two passes** will be allocated to any one publication (photographer/journalist) unless under exceptional circumstances.
3. On publication, copies of recent event reporting etc should be forwarded to the Press Officer at the address below.
4. Photographers are required to submit event 'copyright free' photo discs from previous events for future use.
5. The requirements are waived if the applicant holds a 2012 MSA/FIM Media Credential.
6. The Press Officer reserves the right to refuse to issue or to withdraw any credential for any reason whatsoever.
